**What is Project Fresh?** A program that offers benefits to purchase Michigan grown fruits and vegetables. These benefits can only be used at specific farmer's markets.

**Who is eligible for Project Fresh?** **Current pregnant/breastfeeding women and children over age of 1 year.** Must be active client in the WIC Program to receive benefits.

**How do I get the benefits?** You must go through a class that lasts about 15 minutes. The class explains how and where to use the benefits and what Michigan fruits and vegetables you are able to buy. If you have questions regarding Project Fresh call (989)758-3733.

**What is the \$ amount?** **This year's dollar amount is \$25.00.**

**Where can I use my benefits?** A list of places and vendors for Saginaw County will be provided to you. You can use your benefits in other counties if the farmer is a Project Fresh vendor. Ask before buying.
