## Ways to Calculate Total Annual Income

**Use past month (30 days) check stubs for income verification**

**Gross Income:** Most recent IRS 1040  
(Net Income for Farm and Self-Employed workers)

**YTD:** Divided by # weeks paid x 52 weeks

**Weekly x 52 weeks**

**Every 2 weeks x 26 weeks**

**2 Checks per month 1 pay stub x 24**

**Monthly x 12 months**

**No Income:** Review "No Income" questions to determine if part of another family. If not, record \$0 annual income. Record Self Declared/Verification.

**Adjunct Eligibility** (Medicaid, Food Stamps or FIP): Verify current eligibility. Then client can self declare income.

**Sudden Change in Income:**

**Remember!** You can use 1040 tax with W-2 forms until the next one is filed for documentation.
