

Random ColorCODE Drug Screen Program | Client's Directive:

Random ColorCODE Drug Program:

You are responsible for contacting Saginaw County Health Department Laboratory ColorCODE by calling the hotline or checking the Saginaw County ColorCODE Facebook page, Sunday through Thursday.

Drug Screening Call and Report Procedure:

- Call the Drug ColorCODE Hotline at 989 758-3738 after 8:00 am Sunday through Thursday.
- Listen for your color that was assigned when you enrolled in this program at SCHD.
- If your color is called, you must report for testing to SCHD Laboratory, 1600 North Michigan Ave, Saginaw, MI Room 102 between the hours of 7:30 am – 11:30 am and 12:30 pm – 4:30 pm.
***NOTE: The ColorCODE message stays active throughout the day and normally changes each morning at 8 a.m. If the message has not changed, please call the hotline again by 8:30 a.m.*
- You may also check the "Saginaw County Color CODE" Facebook page for the daily update.
- You are **required** to make an appointment for you service by calling (989) 758-3825 #4 or go to <https://www.picktime.com/schdlabdrugscreening> to schedule your own appointment.
- Masks are required in the building. If you don't have one, we can provide one to you.

Identification:

You **MUST** provide proper identification for each visit. The lab will not call your Probation Officer.

Payment:

You **MUST** have payment at the time of each visit. Preferred forms of payment are cash, money order, credit or debit cards. There is an enhanced access fee to pay with credit/debit cards. Checks are acceptable; there is a \$25 fee for checks returned for insufficient funds.

Number of attempts:

- You will be allowed one attempt. If you cannot provide a sample, you will be instructed to return to your vehicle until our schedule allows you to return. We will contact you when there is availability.
- If you cannot provide a urine sample, you will be reported out as a failure to provide.

Cheaters:

- If a you submit a sample that has been adulterated in any manner, the sample will be reported out as: **"Specimen was rejected due to suspected adulteration or unacceptable temperature. This is the final report for this sample."**
- If you would like to deliver another sample, it will be treated as a new sample and will be charged accordingly.

Enrollment Fee:

There is a one time enrollment fee of twenty-six (\$26.00) to the SCHD Random Drug Screening Program. You **MUST** have payment at the time of enrollment.

Other Information:

- Your Probation Officer will receive your test results, contact them for results.
- If you find that you have a positive test result, confirmatory testing is available within 2 months of specimen collection. Call the laboratory for more information 989.758.3825
